OF  
SHORELINE PRESERVATION COALITION**

**ARTICLE 1  
NAME, ARTICLES OF INCORPORATION**

1.1 Name. The name of this Hawaii nonprofit corporation (the “*Corporation*” or “*SPC*”), which was formed pursuant to the Hawaii Nonprofit Corporations Act, Chapter 414D of the Hawaii Revised Statutes (the “*Act*”), is “SHORELINE PRESERVATION COALITION.”

1.2 Articles of Incorporation. The Articles of Incorporation of the Corporation, dated as of February 1, 2023 (the “*Articles*”), were filed with the State of Hawaii Department of Commerce and Consumer Affairs on February 1, 2023.

**ARTICLE 2  
PRIMARY PURPOSE AND POWERS**

2.1 Primary Purpose. The primary purpose of the Corporation is to serve as a social welfare organization devoted to preserving shorelines in the State of Hawaii by representing the general public’s interests before State of Hawaii and County legislative bodies and administrative agencies and advocating for fair and balanced public policies and solutions that will promote the preservation of shorelines in the State of Hawaii and consider all stakeholders. The Corporation is a non-profit corporation and is not organized to generate profits for any of its members. No part of the Corporation’s net earnings may inure to the benefit of any member or individual.

2.2 Powers. The Corporation shall possess and may exercise all of the powers and privileges granted by the Act or by any other law or by these By-Laws, together with any powers incidental thereto, so far as such powers and privileges are necessary or convenient to the conduct, promotion, or attainment of the purposes or activities of the Corporation.

**ARTICLE 3  
LOCATION OF OFFICE AND REGISTERED AGENT**

3.1 Office. The Corporation shall continuously maintain a registered office in the State of Hawaii as required by the Act, and the Corporation’s principal office and place of business shall be located in the City and County of Honolulu, as determined by the Board of Directors, and as set forth in the Articles from time to time.
